Whereas, high quality early childhood programs increase graduation rates by as much as 44% and improve outcomes for the child, the economy and the community overall; and

Whereas, collecting data and evaluating early childhood programs on a local level is essential to ensuring that our local efforts are evidence-based and are efficient and effective in meeting the needs for young children and families; and

Whereas, developing a better understanding of the importance of early childhood enables the community and individuals to play a crucial role in connecting families to resources and in advocating for local, state, and federal support for local programming; and

Whereas, the Mayors of the Cities of Newton, Conover, Claremont, Maiden, Catawba, and Hickory; and the Chair of the Catawba County Commissioners are strongly committed to participating in Early Childhood Education, and will read to children during the month of May; and

Whereas, all elected officials encourage their citizens to also make the commitment to these programs in order to improve the outcomes for the children in our community;

1. CALL TO ORDER

Mayor David Morrow called the Claremont City Council meeting to order at 7:04 p.m.

2. APPROVAL OF AGENDA

The agenda was approved as presented.

3. INVOCATION & PLEDGE OF ALLEGIANCE

The invocation was led by Bishop George Hilton of Light House Ministry. Councilmember Shawn Brown led the Pledge of Allegiance.

4. MAYOR'S REPORT

Mayor David Morrow reported Council, staff and department heads met February 2nd for the annual budget retreat. On March 11th Mayor David Morrow and City Manager Barrick will be attending a Mayor Manager's meeting. At the meeting they will discuss the economic competitive plan which the EDC was commissioned to see how Catawba County as a whole with sister cities could work together to improve Catawba County. The Amazing Race will be held at the Claremont Elementary School on March 19th. The Amazing Race is a reading competition for students and adults.

5. CONSENT AGENDA

A. February 4, 2013 Regular Meeting Minutes – Mayor Pro Tem Timothy Lowrance made a motion to accept February 4, 2013 regular meeting minutes as presented. Councilmember Nicky Setzer seconded the motion. The motion passed unanimously.

6. CITIZEN'S CONCERN'S & COMMENTS

None

7. PUBLIC HEARING

At 7:15 p.m. Councilmember Nicky Setzer made a motion to open the public hearing. Mayor Pro Tem Timothy Lowrance seconded the motion. The motion passed unanimously.

A. City of Claremont Golf Cart Ordinance – No member of the public commented on the ordinance.

At 7:16 p.m. Councilmember Shawn Brown made a motion to close the public hearing. Councilmember Dale Sherrill seconded the motion. The motion passed unanimously.

8. NEW BUSINESS

A. City of Claremont Golf Cart Ordinance - The City of Claremont has discussed the option to allow Golf Carts on city streets for a few years. Prior to recent changes in the General Statues the use of Golf Carts on Municipal streets required special legislation. This ordinance has been complied based on similar ordinances that have been adopted in other municipalities.

Highlights of this Ordinance include:

- Golf Carts can be operated on streets with a posted speed limit of 35 mph or less.
- Operators must be at least 16 years old and possess a valid NC driver's license.
- Golf Carts may only be operated between sunrise and sunset.
- All golf cart operators must complete a golf cart registration application and submit to the City of Claremont Police Department for approval. Before driving on public roads, the operator of the golf cart must have a valid registration issued.
- All traffic laws applicable to motor vehicles and the operation thereof are applied to Golf Cart operators.

City Attorney Bob Grant stated allowing golf carts on public streets doesn't open the City to any liability but the City can still be sued. On Ball Head Island the only transportation they have is by golf cart. They have had injuries and deaths due to not having seatbelts in the golf carts. He suggested adding a seatbelt regulation to the ordinance. He is also concerned with the golf cart being allowed in areas where the speed limit is 35 mph since a golf cart's maximum speed is 20 mph. He stated he doesn't think insurance companies will insure a golf cart.

Councilmember Dale Sherrill made a motion to table the golf cart ordinance. Councilmember Shawn Brown seconded the motion. The motion passed unanimously.

B. Resolution 15-12 Planning Board Appointments - The Planning Board currently has two member seats open. Planning Board Chairman Robert Smith has recommended reappointing the current members to these positions.

Councilmember Nicky Setzer made a motion to approve resolution 15-12 as presented. Mayor Pro Tem Timothy Lowrance seconded the motion passed unanimously.

9. DEPARTMENT & COMMITTEE REPORTS

- **A. Youth Council** Brittany reported they will be having two spirit nights, one at Boxcar and the other at Bojangles. They will also have three Zumba nights at St. Mark's Lutheran Church. The annual Easter egg hunt is March 23rd with the rain date of March 30th in Claremont Park.
- **B. Fire Department** Chief Gary Sigmon reported fire calls are down and training hours are up, 581 training hours for the month. They are preparing for the pancake breakfast that will be on May 4th. They held a fire extinguisher class for the staff of Bethlehem United Methodist Church daycare.
- C. Police Department Deputy Chief Gary Bost reported Corporal Clay Buff and Officer Pete Carswell investigated a case of breaking and entering into a vehicle at Pierre Foods. Lieutenant Long and Corporal Clark investigated cases of counterfeit monies. Deputy Chief Gary Bost stated counterfeit monies enter the banks and the banks use a machine that tells them rather the money is real or counterfeit. If the money is counterfeit they call the police.
- **D. Public Works** Public Works Director Tom Winkler reported Rick Damron is the new Assistant Director of Public Works. He stated the City loss power at the pump station and Deputy Chief Gary Bost found out who caused the power loss.
- **E. Rescue Squad** Chief Eric Jones reported Tim Hicks, Steve Norris and Eric Jones are going through the North Carolina Structural Collapse Technician Course that is being held at Surry Community College. Some of the up-coming training classes that are scheduled or being scheduled includes an Agricultural Rescue Class, ATV Tracking and Rescue class and some Search classes. The 13th Annual Claremont Rescue Pig Picking and Poker Run is scheduled for April 20th, 2013. We look forward to seeing everyone there this year.
- **F.** Utilities Department City Manager Doug Barrick reported the North Plant flow spiked in December which was caused by a leak at City Hall. January's flow is better. Smoke testing has been completed in the Industrial Park.
- **G. Planning & Zoning** City Planner Laurie LoCicero reported she will be adding extra hours to her time in Claremont. She will now be in Claremont on Wednesday mornings as well as Monday afternoons. The Planning Board is continuing to work on the sign ordinance.
- **H. Parks & Recreation Committee** Mayor Pro Tem Timothy Lowrance reported the committee is working on Claremont Daze. They are revamping the kids area and they are going to let the provider of the rides manage the rides.

10. CITY MANAGER'S REPORT

City Manager Doug Barrick stated DOT will be sending the sidewalk grant contract to be approved at April's meeting. The construction for the sidewalk project is estimated to begin in October and should be completed no later than August 2014.

Mayor David Morrow stated book author Robert Whitlow will be reading at the Claremont Library on March 14th at 6 p.m.

Mayor Pro Tem Timothy Lowrance will be attending the NLC conference in Washington D.C. March 9th through March 12th.

4. INTRODUCTION TO THE BUDGET INFORMATION

City Manager Doug Barrick thanked everyone for their participation in putting the information together for the budget retreat and the FY 2014 budget.

5. OVERVIEW OF FY 2014 BUDGET

For FY 2013 the money comes from:

- 82% Ad Valorem Taxes
- 8% Utility Franchise Fees
- 8% Sales Tax
- 2% Fund Balance
- 1% State Shared Revenues
- 1% Fees

Key Points for N.C. Senate Bill 127 & House Bill 356

Legislation Summary: The draft legislation (edition 1) directs that the regional offices of the North Carolina Department of Environment and Natural Resources (7 offices), divisional offices of the Department of Transportation (14 divisions) and the regional economic development commissions and partnerships (a total of 7) combine into 7 uniform administrative regions in the state. It establishes a Study Commission on Regionalization Conformity no later than September 1, 2013. The commission consists of 8 members with 4 appointed by the Senate Pro Tem and 4 appointed by the House Speaker. The legislation spells out specific issues for consideration. The populations of the proposed administrative regions range from 758,117 to AT COUNCIL O 2,011,175.

Key Points:

- The current boundaries of SB 127/H356 (see map) split many of the regional councils of governments.
- The current bill text places Burke County in a different region from Alexander, Caldwell & Catawba.
- The current bill boundaries split metropolitan areas including RPOs and MPOs.
- The current bill boundaries do not appear to consider travel patterns or economic clusters.
- The current bill boundaries would not significantly improve the existing issue of regional councils of governments, MPOs and RPOs having to work with multiple regional offices of state government.
- The proposed study commission appointments are not designated for any particular agency or category of persons.
- Regional councils of governments are the most prominent and active long-time statewide entities that identify and address issues of regional significance.
- Aligning the state administrative regions with boundaries of regional councils of governments will enhance collaboration between local government, community and business leaders by reducing the number of state administrative regions for which they must interact.





Proposed State Administrative Regional Divisions Aligned with NCARC Boundaries Option A





A RESOLUTION REGARDING THE PROPSED STATE REGION DESIGNATIONS FOR PROVISION OF SERVICES

WHEREAS, The Western Piedmont Council of Governments (WPCOG) was established in 1968 by local governments in its region to address issues of long range planning, economic development and to provide technical assistance to local governments; and

WHEREAS, the U.S. Congress passed the Intergovernmental Cooperation Act in 1970 to promote closer cooperation between federal programs and state and local governments; and

WHEREAS, Regional Councils of Governments were formally established by the State of North Carolina in 1969 (G.S. 160A-470, -478) to promote regional examination of issues, provide assistance to local governments and administer specific programs on behalf of the State and Federal Government; and

WHEREAS, in 1970, an executive order, by the N.C. Governor, designated 17 regions in North Carolina and in 1971, the state announced its Lead Regional Organization policy that directed state agencies to deal with a single regional organization in each designated region of the state for the delivery of services in several departments; and

WHEREAS, the WPCOG Region, and other Council of Governments regions, best represent the economic centers, travel patterns, cultural ties, and physical commonalities of the State of North Carolina; and

WHEREAS, the N.C. General Assembly is considering House Bill 356 and Senate Bill 127 which realign several state agencies into common regional administrative divisions and the proposed boundaries split the WPCOG region by placing Burke County in a separate region from Alexander, Caldwell and Catawba counties; and

WHEREAS, it is reported that the N.C. Department of Commerce may recommend realigning the workforce development areas to match the seven regional economic

partnership boundaries while other reports suggest that the State may eliminate the regional economic partnerships altogether; and

WHEREAS, N.C. General Assembly House Resolution 55 and Senate Resolution 147 support the realignment of workforce development areas with the boundaries of regional councils of governments to promote greater effectiveness and efficiency in the administration of the Workforce Investment Act.

NOW, THEREFORE, BE IT RESOLVED that the Claremont City Council hereby calls on the North Carolina Governor and General Assembly to utilize the boundaries of the WPCOG Region, and other Council of Governments regions, when designating any new boundaries for the provision of workforce development, transportation, or environmental programs and other state or federal programs and resources.

DRAFT Ordinance No. 11-12

AN ORDINANCE TO AMEND THE CLAREMONT CODE OF ORDINANCES TO REVISE SECTION 6-2-25 OF THE CITY CODE OF ORDINANCES

WHEREAS, it is the desire of the Council of the City of Claremont to continually update and revise the Claremont Code of Ordinances in accordance with the needs of the citizens of the City of Claremont; and

WHEREAS, in order to protect the citizens of the City and their properties; and

WHEREAS, the City of Claremont has initiated text amendments to the Claremont Code of Ordinances:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CLAREMONT NC:

Section 6-2-25 Beer and wine consumption; possession of open container; disposal of containers; exception for community sponsored public festivals.

- A. *Definitions*. The following words, terms and phrases, when used in this section, shall have the meanings ascribed to them in this subsection, except where the context clearly indicates a different meaning:
 - a. "ABC permit" or "permits" means any written or printed authorization issued by the Commission pursuant to the provisions of this Chapter, other than a purchase-transportation permit. Unless the context clearly requires otherwise, as in the provisions concerning applications for permits, "ABC permit" or "permit" means a presently valid permit;
 - b. "Alcoholic beverage" means any beverage containing at least one-half of one percent (0.5%) alcohol by volume, including malt beverages, unfortified wine, fortified wine, spirituous liquor, and mixed beverages, as defined by G.S. 18B-101;
 - c. Beer means the same as the term "malt beverage," as defined by G.S. 18B-101;
 - d. "Commission" means the North Carolina Alcoholic Beverage Control Commission established under G.S. 18B-200.
 - e. "Fortified wine" means any wine, of more than sixteen percent (16%) and no more than twenty-four percent (24%) alcohol by volume, made by fermentation from grapes, fruits, berries, rice, or honey; or by the addition of pure cane, beet, or dextrose sugar; or by the addition of pure brandy from the same type of grape, fruit,

- berry, rice, or honey that is contained in the base wine and produced in accordance with the regulations of the United States, as defined by G.S. 18B-101;
- f. "Malt beverage" means beer, lager, malt liquor, ale, porter, and any other brewed or fermented beverage except unfortified or fortified wine as defined by this Chapter, containing at least one-half of one percent (0.5%), and not more than fifteen percent (15%), alcohol by volume. Any malt beverage containing more than six percent (6%) alcohol by volume shall bear a label clearly indicating the alcohol content of the malt beverage, as defined by G.S 18B-101;
- g. "Mixed beverage" means either of the following:
 - a. A drink composed in whole or in part of spirituous liquor and served in a quantity less than the quantity contained in a closed package.
 - b. A premixed cocktail served from a closed package containing only one serving as defined by G.S. 18B-101;
- h. "Nontaxpaid alcoholic beverage" means any alcoholic beverage upon which the taxes imposed by the United States, this State, or any other territorial jurisdiction in which the alcoholic beverage was purchased have not been paid, as defined by G.S. 18B-101:
- i. "Open container" means a container that has a broken seal or a container other than the manufacturer's unopened original container.
- j. "Public street' means any highway, road, street, avenue, boulevard, or other way within and under the control of the city and open to public use, including the sidewalks of any such street.
- k. "Spirituous liquor" or "liquor" means distilled spirits or ethyl alcohol, including spirits of wine, whiskey, rum, brandy, gin and all other distilled spirits and mixtures of cordials, liqueur, and premixed cocktails, in closed containers for beverage use regardless of their dilution, as defined by G.S. 18B-101.
- 1. "Unfortified wine" means any wine of sixteen percent (16%) or less alcohol by volume made by fermentation from grapes, fruits, berries, rice, or honey; or by the addition of pure cane, beet, or dextrose sugar; or by the addition of pure brandy from the same type of grape, fruit, berry, rice, or honey that is contained in the base wine and produced in accordance with the regulations of the United States, as defined by G.S. 18B-101;
- m. "Wine" means the same as the term "unfortified wine," as defined by N.C.G.S. 18B-101.
- B. *Public Consumption Unlawful*. It shall be unlawful for any person to consume any alcoholic beverage, including malt beverages, fortified or unfortified wine, mixed beverages, or other spirituous or other spirituous liquors, all as defined in G.S. 18B-101, upon or within the limits of rights-of-way of any street, boulevard, alley or sidewalk in city parks and buildings, or on any other property owned or occupied by the city.

- C. *Private Premises Consumption Regulated*. It shall be unlawful for any person to consume any alcoholic beverage, including malt beverages, fortified or unfortified wine, mixed beverages, or other spirituous or other spirituous liquors, all as defined in G.S. 18B-101, upon the private business premises of another without permission of the owner or person in control of such premises.
- D. Possession of Open Container in Public Unlawful. It shall be unlawful for any person to possess an open container of alcoholic beverage, including malt beverages, fortified or unfortified wine, mixed beverages, or other spirituous or other spirituous liquors, all as defined in G.S. 18B-101, upon or within the limits of any public right-of-way of any street, boulevard, alley or sidewalk in city parks and buildings, or on any other property owned or occupied by the city.
- E. *Container disposal*. It shall be unlawful for any person to drop, throw, cast or deposit any used container of alcoholic beverage, including malt beverages, fortified or unfortified wine, mixed beverages, or other spirituous or other spirituous liquors, upon any public street or sidewalk or upon the private business premises of another without permission of the owner or person in control of such premises.
- F. Exception; permit required. Consumption of beer and wine and spirituous liquor or mixed beverages is permitted during any community-sponsored public function, festival or celebration being conducted upon and within designated areas of any public street, sidewalk or other property owned or lawfully occupied by the City pursuant to a written permit issued by the city manager or his duly authorized designee to the holder of a valid permit from the Commission applicable to the community sponsored public function, festival or celebration. The permit issued by the city manager or his duly authorized designee shall be consistent with the permit issued to the permittee by the Commission. This permit, when issued, may allow the sale, service and distribution of beer, wine and spirituous liquors, including mixed beverages, on designated streets, sidewalks and areas reserved for the event, subject to all applicable ABC or ALE rules or regulations or laws of the State of North Carolina. The permit issued by the City shall designate the boundary of the area in which sale, service, distribution or consumption of beer and wine or spirituous liquors is permitted and the specific times during which such sale, service, distribution and/or consumption is permitted. The area in which such sale, service, distribution and/or consumption is permitted shall be delineated by barricades, with an entrance into such barricaded area clearly marked; the entrance shall be so constructed as to allow ready control of patrons, including viewing of identification to avoid underage persons being within the barricaded area; no malt beverages or unfortified wine or other alcoholic beverage shall be consumed outside of such barricaded area. Proper application for special permit to the proper state authorities shall be made so that a permit may be received prior to the opening of the special event, and such permit to be available for inspection by the city and its officers at any time. However, before permit is issued under this section, the city manager or his duly authorized designee shall designate the

boundaries of the event and provide for temporarily closing those streets or public areas within the boundaries for general public use during the times the permit is to be effective.

G. *Application for permit*. Application forms for the permit referred to in subsection F of this section are available from the City Manager and must be filed at least 21 days prior to the opening day of the event.

CITY OF CLAREMONT UTILITY SYSTEM MONTHLY UPDATE March 2013

The City of Claremont operates a Utility System that includes two water reciving vaults, two 300,000 gallon elevated water storage tanks, five sewer pump stations, two waste water treatment plants, and roughly 25 miles of sewer and water lines. The two treatment plants are permitted to handle 400,000 gallons of waste water per day with 300,000 allocated to the McLin Creek plant and 100,000 to the North plant. The City of Claremont purchases all of its water from the City of Conover and contracts the operation of the waste water treament plants with the City of Hickory. This report is intended to give a snapshot of the monthly activities of the utility system.
