

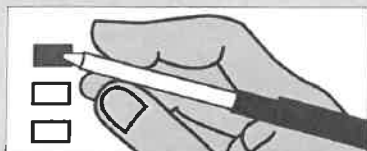

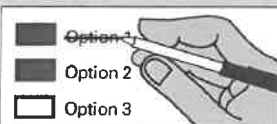
Instructions

Capital Projects Levy to Address Aging
Facilities, Improve Safety and Acquire
Land

The Board of Directors of Deer Park School District No. 414-200-61 adopted Resolution No. 04-2024-25, concerning a proposition to fund specific facility improvements and acquire land. This proposition would authorize the District to levy the following excess taxes, on all taxable property within the District, to improve Arcadia Elementary (replace aged roof and flooring, address outdated gym HVAC, improve safety), make District-wide safety and emergency communication improvements, replace the 90-year-old transportation center, and develop land:

Proposition No. 1

The Board of Commissioners of Stevens County Fire Protection District No. 4 adopted Resolution No. 1-25 concerning a Permanent regular property tax levy for emergency medical services. This proposition would, subject to an annual right of referendum by the voters, authorize a Permanent regular property tax levy of an amount not to exceed fifty cents (\$0.50) per thousand dollars (\$1,000.00) of assessed valuation Permanently beginning in 2025 for collection in 2026 and thereafter, to be used only to provide funding for emergency medical services (EMS), specifically costs related to EMS personnel, EMS personnel training, and EMS equipment. Will Stevens County Fire Protection District No. 4 be authorized to impose a Permanent regular property levy of \$0.50 or less per thousand dollars of assessed valuation?
